C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Through aerial images I was able to confirm common water flow during the regional rainy season, between November and February, and sometimes extending into April in certain years. Based on aerial image analysis and consideration of precipitation data, lower water years occasionally correlated with the channel drying up by mid-February, but this was the exception not the norm. Per the definition of "waters of the United States" defined in 40 C.F.R. §120.2 and clarified in the Joint Memorandum titled *Clean Water Act Jurisdiction Following the U.S. Supreme Court's Decision in Rapanos v. United States & Carabell v. United States*, dated December 2, 2008, non-navigable tributaries of traditional navigable waters that are relatively permanent are jurisdictional.
