is for 'gone'

Jimmy Garoppolo doesn't appear to be the answer to the 49ers' complex quarterback problem.

On Wednesday, San Francisco head coach Kyle Shanahan said he doesn't "see any scenario" in which Garoppolo would be in the 49ers' 2023 plans. That would leave Shanahan with second-year QB Trey Lance and rookie sensation Brock Purdy.

"I know we have two starters on our team right now that I believe we can win with," Shanahan said. "So when you have that situation, you're not that eager to go looking around."

Shanahan's statements seem to mean Garoppolo's tenuous time in San Francisco has reached its end. The 31-yearold was acquired from the Patriots in an October 2017 trade and took over as the 49ers' starter just over a month later. His time with San Francisco was beset by numerous injuries, poor play and constant trade rumors.

Then, the franchise drafted Lance with the third-overall pick in 2021. Garoppolo admitted he was surprised to still be with the 49ers at the start of this season after he had lost the starting job to Lance.

After Lance suffered a season-ending injury to his right

ankle in Week 2, Garoppolo took over again and started the next 10 games, throwing for 2,437 yards and 16 touchdowns with four interceptions. But Garoppolo broke his left foot early in the 49ers' game against the Dolphins on Dec. 4, Purdy took over with his show-stealing heroics.

Purdy led the Niners to the NFC Championship game before San Francisco lost 31-7 to the Eagles. During the first quarter of that game, however, Purdy tore the UCL in his right elbow, an injury that could take six months or more to heal and may require surgery.

Even with both Purdy and Lance, who had surgery on his

ankle in September, injured, Garoppolo seems to be done with the 49ers.

"[Returning] really wasn't on my mind to be completely honest," Garoppolo told reporters earlier this season. "I was training out here, I had to be here, so I was here for that reason. I was just trying to get my body right, get my shoulder right. I felt very confident out there."

Where Garoppolo will land remains to be seen, but several teams are in need of a veteran quarterback — including the Jets, Titans, Dolphins, Panthers, Commanders and Buc-

Brady's dad 'not shocked' at retirement

Tom Brady kept his retirement under wraps for a week.

Brady's father, Tom Brady Sr., told the Boston Globe that his son revealed to him about a week ago that he would be retiring from the NFL for a second time. Brady announced his retirement Wednesday morning.

"We're not shocked by any means," Brady Sr. told the outlet on Wednesday. "He has played football for 32 years out of his 45, living his dream for three-fourths of his life. It's been a wonderful ride. He's very secure in his decision. It's about time."

Brady Sr. and his wife Galynn were on the field after what wound up being their son's final game, a 31-14 wild-card round playoff loss to the Cowboys. Brady kissed his parents as he exited the field and entered the tunnel.

It was a trying season for Brady. While the Buccaneers won the NFC South, their 8-9 record marked the first losing season in Brady's 23-year NFL career.

Brady also finalized a divorce from his wife, model Gisele Bundchen, with the two confirming the news in October after it had been rumored for months. The inseason split was "traumatizing" for Brady, according to ESPN NFL insider Jeff Darlington.

Brady announced his retirement on Wednesday morning with a succinct message on social media.

"Hey guys I'll get to the point right away. I'm retiring. For good," Brady said in an video that he filmed himself on the beach. "I know the process was a pretty big deal last time, so when I woke up this morning I figured I'd just press record and let you guys know first.'
