À day after the Liberty landed superstar free agent Breanna Stewart to instantly vault themselves into the WNBA elite, they have pulled off another coup by bringing in four-time All-Star

point guard Courtney Vandersloot.

Stewart will take "substantially less" than

her maximum contract to help fit Vandersloot under the WNBA's hard salary cap, ESPN reported. Laney may yet be traded to create financial flexibility for the Liberty.

Vandersloot's signing will only add to the conversation heralding the dawn of the superteam era in the WNBA — whether that's to celebrate or bemoan the NBA-like convergence of star players. The Las Vegas Aces, who won the title last season, swooped this offseason to add Candace Parker, giving them four No. 1-overall draft picks in their starting five. The Liberty and Aces now boast a combined seven of the 10 All-Star starters and six of the 10 players who made All-WNBA teams last year.

Vandersloot, who will turn 34 next week, has spent her entire 12-season WNBA career with the Chicago Sky, winning a long-awaited title in 2021. She has led the league in assists six times, and ranks third in WNBA history in assists.

# **Kyrgios pleads guilty** to Aussie assault rap

CANBERRA, Australia Nick Kyrgios had suffered severe depression, suicidal ideation and insomnia in the past, a psychologist told a court on Friday when the Australian tennis star pleaded guilty to pushing a former girlfriend to the ground two years ago.

The 2022 Wimbledon runner-up pleaded guilty in the Australian Capital Territory Magistrates Court to assaulting Chiara Passari during an argument in his hometown of Canberra in January 2021.

Magistrate Jane Campbell did not record an conviction against Kyrgios for reasons including that the offense was at the low end of seriousness for a common assault, and was not premeditated.

Campbell described it as an act of "stupidity" and "frustration."

Kyrgios' psychologist, Sam Borenstein, said in a written report and testimony by phone that Kyrgios had suffered major depressive episodes in the past and had used alcohol and drugs to cope. Kyrgios' mental health led to impulsive and reckless behavior.
