SUBJECT: Performance Audit of Department of Labor's (DOL) and state workforce agencies' (SWAs') efforts to address potentially fraudulent Unemployment Insurance (UI) claims submitted by multi-state claimants.

Please be advised that Regis & Associates, PC has been engaged by the Department of Labor, Office of Inspector General (DOL-OIG); and is initiating a performance audit of the DOL's and SWAs' efforts to address potentially fraudulent UI claims submitted by multi-state claimants. We will contact your audit liaison to schedule an entrance conference to discuss the following:

Objective: The purpose of the performance audit is to determine to what extent DOL and SWAs have taken action to follow up on potentially fraudulent CARES Act UI claims filed by claimants in two or more states.

Scope: The scope of this audit will focus in-depth on actions taken by ETA and 10 selected SWAs to address potentially fraudulent UI claims from April 7, 2021 through the date of this letter. The remaining 44 SWAs will be surveyed.

Fieldwork Location: Virtual

Mandatory Timeframe: The final audit report is due to DOL-OIG by March 15, 2023.

We plan to begin work immediately after our entrance conference and would appreciate you notifying appropriate SWA officials of our plans. To facilitate the start of the audit, we have attached an initial documents and data request
