Subject: Changes to River Forecast (RVF) Products issued by  
          Middle Atlantic River Forecast Center effective  
          January 27, 2021

Effective January 27, 2021, at 8 am EST (1300 UTC), the NWS Middle Atlantic River Forecast Center (MARFC) is changing the content and product identifier codes of its River Forecast (RVF) products. In an effort to improve service, NWS will change the Product Identification List (PIL) headers (PITRVFXXX) to better match the forecast point locations represented in each text product. The content of each RVF product will also change, including which forecast points appear in each product.

MARFC will continue to provide river forecast service for all existing forecast points.
