Subject:      Changes to Public and Fire Weather Zones for NWS  
              Weather Forecast Office New Orleans/Baton Rouge, LA:  
              Effective March 22, 2022

Effective on or about Tuesday, March 22, 2022, at 3:00 PM Central Daylight Time (CDT), 2000 Coordinated Universal Time (UTC), the NWS Weather Forecast Office in Slidell, Louisiana (LIX) will change Public and Fire Weather Forecast Zones encompassing St. Tammany, Tangipahoa, Livingston, Ascension, Jefferson, Plaquemines and St. Bernard Parishes in southeast Louisiana. After this change, all public and fire forecasts and related products will use the new zone numbers and names shown below.

If March 22, 2022 is declared a Critical Weather Day, this implementation will be postponed to Tuesday, March 29, 2022.

These changes are intended to provide increased flexibility and improved accuracy of forecast, watch, warning, and advisory products in the public and fire weather programs.

The existing zones are being reconfigured to optimize issuance of coastal flood and storm surge hazard products for conditions that vary significantly from the immediate coast to areas farther inland, and to better differentiate between areas inside and outside of the Hurricane and Storm Damage Risk Reduction System levees.
