Subject: Updated: Changes to Public and Fire Forecast Zones for  
          WFO Northern Indiana, Effective September 13, 2022

Updated zone change implementation date from September 7, 2022 to  
September 13, 2022.

Effective Tuesday, September 13, 2022, at 4:00 PM Eastern Daylight Time (EDT), 2000 Coordinated Universal Time (UTC), the NWS Weather Forecast Office in Northern Indiana (IWX) will complete changes to Public and Fire Weather Forecast Zones encompassing Berrien county in southwest Michigan and La Porte, St. Joseph and Kosciusko counties in northern Indiana. After this change, all public and fire weather forecasts and related products will use the new zone numbers and names shown below.

If September 13, 2022 is declared a Critical Weather Day, this implementation will be postponed to September 14, 2022 at 2000 UTC.

Four current zones will be subdivided into 8 separate zones. These changes are intended to provide increased flexibility and improved accuracy of forecast, watch, warning, and advisory products in the public and fire weather programs.
