




Natomas Levee Construction Update

JULY 2022

Reach A Gateway Oaks Dr to Farm Rd	Site preparation underway with tree removal resuming Fall 2022. Levee construction to begin Summer 2022 Improvements to Pumping Plant 1B, City Sump 160 and Pumping Plant 1A to begin in 2023.	
Reach B San Juan Rd to Elverta Rd	Levee construction began July 2020; expected to be completed Fall/Winter 2022. Pumping Plant #3 – Construction completed and plant is operational. I-5 Window - Construction to begin Spring 2022; expected to be completed Winter 2022/2023. Riverside Pumping Plant Replacement to begin Summer 2022 with discharge pipe relocation to begin 2023 Elkhorn Pumping Plant construction to begin 2023.	
Reach C Elverta Rd to Sankey Rd	Levee construction was completed in 2008/2009 by Sacramento Area Flood Control Agency. Pritchard Lake Pumping Plant to begin construction in 2024.	
Reach D Sankey Rd to Howsley Rd	Levee construction was completed in 2008/2009 by Sacramento Area Flood Control Agency. Highway 99 Window – Construction expected to begin Spring 2024. Pumping Plant #4 – Construction began August 2021; expected to be completed Fall 2022 / Winter 2023.	
Reach E Howsley Rd to Sankey Rd	Levee construction expected to begin Spring 2023.	
Reach F&G Sankey Rd to Drainage Pumping Station	Levee construction and improvements to the levee slope and Pumping Plant #6 expected to begin Spring 2025.	
Reach H Drainage Pumping Station to Northgate Blvd	Levee construction and improvements to Pumping Stations #8 and #102 began 2018; expected to be completed Fall 2022.	
Reach I Northgate Blvd to Gateway Oaks	Contract 1: Levee construction and improvements to Pump Station #58 completed Fall 2022. Contract 2: Landside levee improvements and installation of maintenance road expected to begin Summer 2023.
