### **X5**RETAILGROUP **Q2** and H1 Operational Highlights


- Acceleration of sales and LFL results in Q2
  - 2Q Soft Discounter sales **increased by 16%**, LFL **sales higher by 2.1%**
- June 2012 LFL sales increase to positive 2.9%
  - Soft Discounters' and Supermarkets' LFL increase by 7% and 2%, respectively
- **Delivering** on Kopeyka **30% increase** in June LFL sales
- Strong organic growth in 1H 2012 ~40% y-o-y increases in new stores and ~90% increase in new selling space





Total Net Retail Sales Growth, % y-o-y




#### Supermarkets Net Retail Sales Growth, % y-o-y

#### Hypermarkets Net Retail Sales Growth, % y-o-y






Total LFL Sales Growth, %




Supermarkets LFL Sales Growth, %




















