X5RETAILGROUP **Q2** and H1 Operational Highlights


- Acceleration of sales and LFL results in Q2
 - 2Q Soft Discounter sales **increased by 16%**, LFL **sales higher by 2.1%**
- June 2012 LFL sales increase to positive 2.9%



Total Net Retail Sales Growth, % y-o-y




Supermarkets Net Retail Sales Growth, % y-o-y

Hypermarkets Net Retail Sales Growth, % y-o-y






Total LFL Sales Growth, %




Supermarkets LFL Sales Growth, %



















Net Retail Sales, mln








