CHARITIES CAN ALSO REQUEST TO BE EVALUATED. PRODUCES A WISE GIVING GUIDE MAGAZINE THREE TIMES PER YEAR, WHICH INCLUDES A SUMMARY LIST OF CHARITY EVALUATIONS. CHARITIES THAT MEET ALL 20 STANDARDS ARE CALLED BBB ACCREDITED CHARITIES. THERE IS NO CHARGE FOR CHARITY ACCREDITATION AND THE RESULTING REPORTS ARE FREE TO THE PUBLIC AT GIVE.ORG. IT AIMS TO PROTECT DONORS' PERSONAL DATA BY USE OF THE ARDOR BLOCKCHAIN. DATA IS ONLY PASSED ON TO THE CHARITY WITH THE DONORS' CONSENT. IT ALSO ENABLES DONORS TO DONATE WITH CRYPTOCURRENCY.

DURING 2021, BBB WGA CONTINUED TO HOLD A SERIES OF NO-CHARGE VIDEO MEETINGS WITH CHARITY EXECUTIVES. THIS WAS INTENDED TO SERVE AS A VIRTUAL WORKSHOP SERIES WHERE BBB ACCREDITED CHARITIES CONNECT AND INTERACT WITH EXPERTS AND COLLEAGUES IN THE CHARITABLE SECTOR TO DISCUSS HOW THEY WERE COPING DURING THE PANDEMIC AND OTHER CHARITABLE
