1. TO ALL WHOM IT MAY CONCERN:

Land Reclamation Group, LLC (LRG) has submitted a prospectus to the Pittsburgh District Corps of Engineers to develop and operate the Shrader Hollow Mitigation Bank. This does not constitute an application for regulated work in Waters of the United States. The 2008 Mitigation Rule defines mitigation banks as a site, or suite of sites, where resources (e.g. wetlands, streams, riparian areas) are restored, established, enhanced, and/or preserved for the purpose of providing compensatory mitigation for impacts authorized by DA permits pursuant to Section 10 of the Rivers and Harbors Act of 1899 and/or Section 404 of the Clean Water Act. In general, units of restored, established, enhanced, or preserved wetlands or streams are expressed as "credits" which may subsequently be withdrawn to offset "debits" incurred at a project development site(s). The Corps, in conjunction with input from the Interagency Review Team (IRT), is responsible for authorizing the use of a particular mitigation bank on a project specific basis and determining the number and availability of credits required to compensate for proposed impacts. The purpose of this Public Notice is to inform you of the proposed mitigation bank and to solicit your comments and information to better enable us to make a reasonable decision on factors affecting the public interest.

- 2. <u>INTERAGENCY REVIEW TEAM</u>: As indicated in the Corps regulations (33 CFR 332.8(b)), the district engineer will establish an IRT to review documentation for the establishment and management of mitigation banks and in-lieu fee (ILF) programs. The primary role of the IRT is to facilitate the establishment of mitigation banks and/or ILF programs through the development of mitigation banking or ILF program instruments. The IRT reviews draft prospectuses, prospectuses, instruments, and other documents and provides comments to the Corps.

4. <u>LOCATION</u>: The site is a 120 acre property that straddles Shrader Hollow Road in Hempfield Township, Westmoreland County, Pennsylvania. The site is in the Youghiogheny HUC 8 Watershed and the Lower Sewickley HUC 12 watershed. This area is depicted in both the Greensburg and Mount Pleasant USGS Quadrangle. The principal tributary through the property is an unnamed tributary of Sewickley Creek. LRG is naming this stream Long Run for the family who developed the farm that the Shrader Hollow Mitigation Bank is situated on. The

5. PURPOSE AND DESCRIPTION OF WORK: Currently Long Run and its tributaries are deeply incised on the property providing little area for the stream to flood outside the channel during a high flow event. Long Run and its tributaries are eroding the existing stream banks and cutting into the bed. The streams are carrying sediments downstream depositing them in culverts and Sewickley Creek. LRG proposes to reestablish the perennial stream channel by raising the stream bed elevation and connecting it to the flood plain. The existing stream will be reestablished into a natural stream channel and will no longer act as a drain for the landscape. It will be reconnected to the flood plain providing natural functional processing of the nutrients within the natural system. In addition to the reestablishment of Long Run and other tributaries on the property, the proposed removal of tile drain systems will restore the water table and reestablish wetland adjacent to Long Run. This activity is expected to reestablish wetlands throughout the valley. See the below tables for existing and proposed resource amounts and proposed work types:

7. <u>IMPACT ON NATURAL RESOURCES</u>: The District Engineer has consulted the most recently available information and has determined that the project may affect, but is not likely to adversely affect endangered species or threatened species, or result in destruction or adverse modification of habitat of such species which has been determined to be critical. This Public Notice serves as a request to the U.S. Fish and Wildlife Service for any additional information they may have on whether any listed or proposed to be listed endangered or threatened species may be present in the area which would be affected by the activity, pursuant to Section 7(c) of the Endangered Species Act of 1972 (as amended). If the U.S. Fish and Wildlife Service concurs with the may affect, not likely to adversely affect determination please respond with written

concurrence.

- 8. <u>IMPACT ON CULTURAL RESOURCES</u>: The National Register of Historic Places has been consulted, and it has been determined that there are no properties currently listed on the register which will be affected by the undertaking. The project, as proposed, will have no adverse effect on Historic or Cultural properties. If we are made aware, as a result of comments received in response to this notice, or by other means, of specific archeological, scientific, prehistorical, or historical sites or structures which might be affected by the proposed work, the District Engineer will immediately take the appropriate action necessary pursuant to the National Historic Preservation Act of 1966 Public Law 89-665 as amended (including Public Law 96-515).
- 9. <u>PUBLIC INVOLVEMENT</u>: Issuance of a public notice regarding proposed mitigation banks is required pursuant to the "Compensatory Mitigation for Losses of Aquatic Resources; Final Rule," (Rule) as published in the April 10, 2008, Federal Register, Vol. 73, No. 70, Pages 19594-19705 (33 CFR Parts 332). The United States (U.S.) Army Corps of Engineers' (Corps) is soliciting comments from the public, Federal, state, and local agencies and officials, Indian Tribes and other interested parties in order to consider and evaluate this proposed mitigation bank.
- 10. EVALUATION: Interested parties are invited to state any objections they may have to the proposed work. The decision whether to issue a permit will be based on an evaluation of the probable impact including cumulative impacts of the proposed activity on the public interest. That decision will reflect the national concern for both protection and utilization of important resources. The benefit which reasonably may be expected to accrue from the proposals must be balanced against its reasonably foreseeable detriments. All factors which may be relevant to the proposal will be considered including the cumulative effects thereof; among those are conservation, economics, aesthetics, general environmental concerns, wetlands, historic properties, fish and wildlife values, flood hazards, flood plain values, land use, navigation, shoreline erosion and accretion, recreation, water supply and conservation, water quality, energy needs, safety, food and fiber production, mineral needs, considerations of property ownership and, in general, the needs and welfare of the people. Any comments received will be considered by the Corps of Engineers to determine whether to issue, modify, condition or deny approval for this proposal. To make this decision, comments are used to assess impacts on endangered species, historic properties, water quality, general environmental effects, and the other public interest factors listed above.
- 11. <u>RESPONSES</u>: Written statements concerning the proposed activity should be received in this office on or before the closing date of this Public Notice in order to become a part of the record and to be considered in the final determination. Any objections which are received during this period may be forwarded to the applicant for possible resolution before the determination is made whether to approve or deny the request.
