Introduction

The S.C. Solid Waste Policy and Management Act of 1991 (Act) – S.C. Code of Laws § 44-96-140 – requires state agencies and state-supported colleges/universities to:

- Provide recycling programs for the collection of selected materials including aluminum, cardboard, glass, lead-acid batteries, paper, plastic, tires and used motor oil;
- Make necessary modifications to their programs to ensure material is recycled to the maximum extent possible; and
- Report the type and amount of material recycled as well as all products purchased containing recycled-content material each year to the S.C. Department of Health and Environmental Control (DHEC). The Act [Section 44-96-140 (E)] also sets a goal that at least 25 percent of all product purchases contain recycled-content material.

DHEC is required to submit a report on this information to the Governor and General Assembly by November 1 of each year. This

report reflects recycling and buying recycled activities for fiscal year (FY) 2022 (July 1, 2021 to June 30, 2022).

Data for this report is submitted directly from the state agency or college/university. DHEC quantifies the reporting from the completed annual survey or from vendors providing recycling services. As for FY22, state agencies and colleges/universities recycled 16,293.25 tons of material – a 30 percent decrease from FY21.

In recent years, the rising cost of recycling services and the COVID-19 pandemic have contributed to fluctuations in recycling totals. FY22 totals reflect state agencies and colleges/universities adjusting to post-pandemic operations.

A total of 64 state agencies independently reported, 2 state agency complexes (collectively 29 agencies) and 22 colleges/universities (a combination of public and private). The Act only requires public colleges/universities to report.

State Agencies


State agencies reported recycling 4,876.30 tons of material – 37 percent increase from FY21.

Material with a significant increases include:;

- Glass went from 9.21 tons in FY21 to 85.18 tons in FY22;
- Office paper increased from 327 tons in FY21 to 822.28 tons in FY22; and
- Metal increased from 764.14 tons in FY21 to 2,486.51 tons in FY22.

Total number of agencies reported in FY22 was 64 state agencies and one state agency complex (collectively 20 agencies). Due to the housing of state agencies within multi-office buildings and complexes, those located within the Capitol Complex (State House grounds) and the Capitol Center (Gervais Street) are reported under those titles. State agencies within these structures who reported numbers are listed as individual agencies.


Colleges/Universities

Twenty-two colleges/universities (both public and private) reported recycling 11,417.22 tons of material – a 42.26 percent decrease from FY21.

Material with significant changes included:

- Glass the amount recycled doubled from FY21 to FY22;
- Organics collection increased from FY21 to FY22; and
- C&D debris recycling decreased from FY21 to FY22.

Santee Cooper

The recycling activities of Santee Cooper, a stateowned electric utility, are separated from traditional state agency reporting.

This is done due to the significant differences between the company's recycling and that of other state agencies. For example, Santee Cooper recycles traditional commodities but also has recovery programs for gypsum ash/pond ash/fly ash – items that are recovered in significant amounts. Given that, this separation from other agency numbers provides a more realistic picture of the recycling of conventional state agencies.


Santee Cooper recycled 1,729,385.05 tons of material in FY22 – compared to 1,676,332.25 in FY21, reflecting a 3 percent increase.

Material with significant increase for FY22 include:

- 36.60 tons of used motor oil filters;
- 1.35 tons of fluorescent bulbs; and
- 1,246,779.62 tons of other material including bottom ash, fly ash and pond ash.

The No. 1 material recovered by the state-owned utility was bottom ash/pond ash/fly ash which comprised 72 percent of its recycled materials.

Buying Recycled

The percentage of state purchases that contain recycled material cannot be determined because no statewide system to track those purchases exists. Still, reporting state agencies and colleges/universities confirmed purchasing recycled-content products during FY22. The recycled-content products purchased most frequently by reporting state agencies and colleges/universities were office paper, bathroom paper products, inkjet/toner cartridges and business cards.
