## Introducing the 988 Crisis Systems Response Training and Technical Center (CSR-TTAC)

The Substance Abuse and Mental Health Services Administration (SAMHSA) has selected Altarum to provide training and technical assistance support to States, Territories, Tribal Organizations, and community partners across the 988 Suicide and Crisis Lifeline and crisis continuum of care. Along with our partners, W2 Consulting Corporation and Change Matrix, LLC, who have extensive experience with behavioral health, crisis services, technical assistance, and health equity, the CSR-TTAC was formed to support the continued growth of the 988 Lifeline and build a more robust crisis care system.

The goal of the CSR-TTAC is to support a crisis care system that is integrated, sustainable, equitable, and aligned around evidence-based and evidenced-informed practices.

#### **COMMUNITY CORNER**



As 988 continues to be a greater part of communities around the country, it is important for jurisdictions to understand the actions States are taking to further embed 988 and strengthen their crisis care systems. In this section of the newsletter, we will provide information and updates from States detailing their plans and progress toward advancing 988 and improving crisis care within their borders.

#### Wyoming:

Wyoming is working to address its suicide rates and improve their crisis care system by advocating for additional funding for the 988 Lifeline in an effort to decrease the State's high suicide rate. Read Funding for 988, infrastructure among governor recommendations.

#### Kansas/Missouri:

#### North Carolina:



#### **DID YOU KNOW?**

988 has American Sign Language (ASL) capabilities!

To expand access to behavioral health for underserved communities, the 988 Suicide & Crisis Lifeline has added ASL to its repertoire. People who are Deaf, DeafBlind, DeafDisabled, Hard of Hearing, and Late-Deafened now have access to the same 988 services as all other people living in the United States.

To connect to a Lifeline counselor in ASL, simply click the "ASL Now" button on <u>988lifeline.org</u>. Also, ASL callers can call **1-800-273-TALK** (8255) from their videophone to reach ASL services.

To promote these capabilities, go to the <u>SAMHSA 988</u> <u>Partner Toolkit page</u>, scroll down to "988 ASL Services". There you will find social media sample posts, suggested Alt Text, and graphics.
