FAQ

- Q: What Technical Assistance will be available for a first-time applicant?
- A: Regarding Technical Assistance, please review Required and Allowable Activities; pages 7-10 of the NOFO. Grant funds can be spent to "Participate with supported employment organizations to obtain technical assistance to implement and sustain evidence-based supported employment and adhere to fidelity" thus, funds can be used for technical assistance for specific purposes.
- Q: We are considering submitting an application for this RFA but wanted to get some clarification regarding on the expected scope of this grant and is it intended for a statewide agency such as DCF or DOL?
- A: Regarding eligibility, "eligible applicants are States and Territories, including the District of Columbia, political subdivisions of States, Indian tribes, or tribal organizations (as such terms are defined in section 5304 of title 25), health facilities, or programs operated by or in accordance with a contract or award with the Indian Health Service, or other public or private non-profit entities." Please review pages 17 and 48 of the NOFO to determine whether your organization falls within the established criteria for eligibility.
- Q: We are excited about this funding opportunity and our interest is in serving transition age youth. Our experience with transitional age young people is that services are more effective and the outcomes are greater when we begin at the ages of 16 or 17. What is the possibility that we could include 16 or 17 year olds in our targeted population for this funding application?
- A: Please review pages 4 and 6 of the FY 2023 NOFO titled Transforming Lives Through Supported Employment for specifics about the recipients of Supported Employment services. The grant funds services for adults.

- Q: As I prepare the grant proposal, I wanted to ask if there was any webinars, presentations or meetings I could attend to help guide us through the process.
- A: The PowerPoint presentation from the Pre-Application Webinar is available on the SAMHSA website. Additionally, please note the budget guidance starting on pg. 76.
- Q: It is stated that this program will increase capacity to implement SEP models. It is also stated that each mental health provider organization must have at least two years of experience providing relevant services. Should this be interpreted as two years experience providing IPS SE to fidelity? Does the grant require that we have been implementing IPS SE fully for 2 years with fidelity or would our current status also meet eligibility?
- A: Please describe your experience as an organization working with persons with serious mental illness and vocational rehabilitation. Per the NOFO, pg., 18 applicants must document two years' experience providing relevant services. The NOFO **does not** specify that such services must be in fidelity with IPS.
- Q: In addressing behavioral health disparities, the DIS is said to identify racial, ethnic, sexual and gender minority and rural populations at the highest risk for experiencing behavioral health disparities. Underserved populations are defined in the NOFA by the factors of race, ethnicity, gender identity and sexual orientation. As a rural state with geographic areas experiencing limitations to access to evidence-based supported employment, would addressing rural populations address the grant requirements regarding health disparities and under-served populations?
- A: Per pages 25 and 60 of the NOFO, please describe in your grant application service gaps and disparities in your community and how you plan to engage underserved groups in your area. It is not required that your organization is located in an area with high rates of underserved persons. What we ask is that you indicate in your application the service gaps and disparities in your community and how you plan to engage underserved groups.
- Q: Is there a specific training on the Behavioral Health CLAS standards that program staff are required to attend or can we provide in-house training on the standards?
- A: Per pg. 8 of the FY 2023 NOFO Transforming Lives Through Supported Employment grant recipients are required to provide training on CLAS standards to all program staff. There are no specific trainings that are required related to training on CLAS standards. An organization can provide the training in-house.

- Q: Are costs related to employment for clients such as uniforms, work shoes/boots, tools, food handler permits, a CDL license, school supplies, car repairs, gas or other items needed for employment allowable?
- A: Issues related to the budget for these costs will be discussed after award of the grant. In general, please review the required and allowable activities, pages 7-11 of the FY 2023 NOFO Transforming Lives Through Supported Employment for allowable costs.
- Q: We would like to offer all program participants digital literacy training (including computer skills) to help with employability. Can we include the trainer for this class as part of the program staff?
- A: Issues related to budget for these costs will be discussed after award of the grant. In general, look at the required and allowable activities, pages 7-11 of the FY 2023 NOFO Transforming Lives Through Supported Employment for allowable costs.
- Q: Is a bridge internship program an allowed expense for those clients who do not feel ready for permanent employment and need to develop the soft skills related to keeping employed? They would be paid during the internship with grant dollars.
- A: Please review the evidence-based supported employment model that you select for such guidance. Typically, Supported Employment is concerned with competitive and integrated employment and not volunteer or internship experiences. Information about Supported Employment models required for the grant can be found on pg. 8 of the FY 2023 NOFO Transforming Lives Through Supported Employment.
- Q: We are a not-for-profit provider of mental health and substance use services. Do we fit the definition of "health facility" for the purposes of eligibility for SM-23-008 FY2003 Transforming Lives Through Supported Employment Program?
- A: Not-for-profits are eligible to apply as long as they are domestic organizations. The term "health facility," noted in the Eligibility section on pg. 17 of the NOFO refers to

health facilities operated in accordance with a contract or award with the Indian Health Service.
