Notification for Extension of date of submission CTAE Alumnus Awards: 2022

The CTAE Alumni Society invites nominations from any member of the CTAE faculty or any member of CTAE alumni society for the "CTAE Alumnus Awards" instituted by CTAE Alumni Society, Udaipur to recognize and honour those alumni who brought laurels to their Alma matter by making significant and outstanding contributions to their profession, their businesses, and/or to the society.

In all maximum of 15 awards will be considered every year viz. Meritorious Service Award (3); Distinguished Alumni Award (3); Senior Professional Engineer Award (3); Professional Engineer Award (3); Young Professional Engineer Award (3). The awards will be considered in three categories as **Academic, Professional and Corporate or Enterprises** or Others. The number of awards can be decreased if no incumbents deserve as decided by selection committee. The awards will be in broad areas of engineering profession like: Professional management of business; Entrepreneurship; Engineering education- Academics & Research; Execution of Engineering Technology for the benefit of Society/masses. The awards will be declared/presented in the form of a plaque/certificate or agitation at the time of ensuing alumni meet cum felicitation programme scheduled on Saturday, October 8th 2022.

Eligibility: Any CTAE alumnus who satisfies the following conditions is eligible for the award:

- He/She must have completed B.E./B.Tech. Or M.E. / M.Tech or PhD Degree programmes from CTAE.
 - He/She must be an active member
 - He/She should have made outstanding contribution to one or more areas listed above.
 - He/She must have served to the cause of enhancing engineering profession.
- Minimum experience in the profession and duration of membership of society for the above awards will be as follows

Interested alumnus submits a typed application along with mentioning why he/she considers himself/herself eligible for the award with the application. Applicants are requested to mention the membership no. (Available at www.ctaealumnisociety.org) clearly in the application.

Selection Process: The selection committee will be constituted by the Patron/Dean CTAE to select the awardees. The selection will be on the basis of following criteria:

He / She should have made significant and outstanding contribution to one or more of the fields of engineering profession such as Professional management of businesses, Entrepreneurship, Academic-teaching and or research, Public life or social entrepreneurship. The contribution should have resulted in a significant impact in terms of (a) dissemination of creation of engineering knowledge,(b)enrichment of lives of people, (c) distribution or creation of wealth, or (d) promotion or establishment of high ethical standards in private or public life. He / She should be a person of high integrity and stature, and one whose contributions will not only make his alma mater proud but will inspire CTAE students, faculty, staff and alumni.

Last Date: The soft/hard copy of duly signed nomination with complete CV, name of award for consideration, testimonials, etc. should reach the office of Alumni Society by 5:00 pm on **September 25th 2022** for the year 2021-2022.
