# Instructions for REAP 2024 Round 7 Reporting (Upward Movement of Rajasthan Candidates)

The candidates who have been allotted College of Technology and Engineering, Udaipur (College Code 1006) in Round 7 of REAP 2024 counselling must read the following important instructions for reporting at the college:

### **Reporting Date and Time**

- Those applicants who have been allotted College of Technology and Engineering (College Code 1006), MPUAT, Udaipur in Round 7 of REAP Counselling are instructed to report physically at college for document verification and fee deposition as per REAP schedule during working hours on university working days. The last date for reporting in this round is 29-08-2024 (5:00 PM) as per the REAP schedule. After that, no reporting will be considered in any circumstances.
- Candidates may report on any working day from 23-08-24 to 29-08-24 as REAP 2024 schedule. Please note that 25-08-24 (Sunday) and 26-08-24 (Shri Krishan Janmashtami) are the holiday.
- Candidate may report during working hours of college i.e. between 10 AM to 5:00 PM.

## Fee at the Time of Reporting

 (SFS/GAS) are given in TABLE I below. If any candidate has already
 deposited a fee at another institute allotted through REAP 2024 Round 6
 (Rajasthan Candidates) that amount will be adjusted in the applicable fee

**2024 allotment and admission letter.** Those who have already deposited a **higher amount** at the previously reported institute in comparison to the applicable fee at CTAE, need to deposit **only Rs 350/-** UG registration fee which will be refunded in the final settlement.

- Original Class 10+2 (XII) or Equivalent exam Mark sheet along with two photocopies
- 10. Medical Fitness Certificate as per REAP-2024 format
- 11. Original Rajasthan Domicile Certificate along with one photocopy

- 14. Income Certificate (financial year 2023-24) in the prescribed format of the state government (if applicable) as per REAP-2024 format (Required for EWS/ Non-Creamy layer OBC/MBC category candidates).

- 16. Original Character Certificate along with one copy
- 17. Original cancelled Bank cheque of the applicant or photocopy of the front page of the candidate's bank account
